Re: Opening City Council Meetings with Prayer

Dear Mayor McGrady and Members of the City Council:

I have the honor of serving as the VP of Operations of the Congressional Prayer Caucus Foundation. The Foundation serves nearly 100 members of Congress who are part of the Congressional Prayer Caucus (the names of those members of Congress who serve on the Congressional Prayer Advisory Team are listed on the left).

In addition, the Foundation serves a network of Legislative Prayer Caucuses in over 40 states, including Maryland, which have over 1,000 state senators and state representatives as members. These leaders are working together to preserve the integrity of our founding principles and to protect First Amendment rights for all.

We have learned from recent news stories that an attorney from the American Humanist Association (“AHA”) contacted the City Council and urged the Council to discontinue the City’s longstanding practice of starting City Council meetings with prayer that often end “in Jesus’ name.” We further understand from news sources that AHA has threatened legal action if the City Council chooses not to discontinue prayer before meetings.

Public officials praying for divine wisdom, and asking citizens to pray with and for them, is certainly nothing new in our nation’s history. George Washington issued the first presidential call to prayer on October 3, 1789. He wrote, “It is the duty of all nations to acknowledge the providence of Almighty God, to obey his will, to be grateful for his benefits, and humbly to implore his protection and favor.” Since then, there have been over 130 presidential calls to

prayer, and in 1952 President Harry Truman signed a law making the National Day of Prayer an annual event.

The legislator contended that this practice violated the First Amendment's Establishment Clause, a contention soundly rejected by the Supreme Court. Perhaps just as important as the ruling were Chief Justice Burger's following words on behalf of the Court:

The opening of sessions of legislative and other deliberative public bodies with prayer is deeply embedded in the history and tradition of this country. From colonial times through the founding of the Republic and ever since, the practice of legislative prayer has coexisted with the principles of disestablishment and religious freedom. In the very courtrooms in which the United States District Judge and later three Circuit Judges heard and decided this case, the proceedings opened with an announcement that concluded, "God save the United States and this Honorable Court." The same invocation occurs at all sessions of this Court. 463 U.S. at 786.

After reviewing the colonial practice of opening legislative sessions with prayer, the Chief Justice reviewed the practice of the First Congress, and noted:

On Sept. 25, 1789, three days after Congress authorized the appointment of paid chaplains, final agreement was reached on the language of the Bill of Rights . . . Clearly the men who wrote the First Amendment Religion Clause did not view paid legislative chaplains and opening prayers as a violation of that Amendment, for the practice of opening sessions with prayer has continued without interruption ever since that early session of Congress. It has also been followed consistently in most of the states . . . 463 U.S. at 788-89.

These principles in *Marsh* were reaffirmed six years ago in *Town of Greece v. Galloway*, 134 S. Ct. 1811 (2014), a case cited by AHA. In *Town of Greece*, the Supreme Court once again held that opening government meetings in prayer is constitutionally permissible. In his opinion for the Court, Justice Kennedy highlighted our nation's historic use of legislative prayer, further stating that "the First Congress provided for the appointment of chaplains only days after approving language for the First Amendment [which] demonstrates that the Framers considered legislative prayer a benign acknowledgment of religion's role in society. . . . As a practice that has long endured, legislative prayer has become part of our heritage and tradition, part of our expressive idiom, similar to the Pledge of Allegiance, inaugural prayer, or the recitation of 'God Save the United States and this honorable Court' at the opening of this Court's sessions." *Id.* at 1819, 1825.

Justice Kennedy in *Town of Greece* rejected claims that prayers before meetings are divisive. Justice Kennedy wrote: “These ceremonial prayers strive for the idea that people of many faiths may be united in a community of tolerance and devotion. Even those who disagree as to religious doctrine may find common ground in the desire to show respect for the divine in all aspects of their lives and being. Our tradition assumes that adult citizens, firm in their own beliefs, can tolerate and perhaps appreciate a ceremonial prayer delivered by a person of a different faith.” *Id.* at 1823.

Chief Justice Burger in *Marsh v. Chambers*, 463 U.S. 792 provides a good conclusion:

In light of the unambiguous and unbroken history of more than 200 years, there can be no doubt that the practice of opening legislative sessions with prayer has become part of the fabric of our society. To invoke Divine guidance on a public body entrusted with making the laws is not, in these circumstances, an “establishment” of religion or a step toward establishment; it is simply a tolerable acknowledgment of beliefs widely held among the people of this country. As Justice Douglas observed, “[w]e are a religious people whose institutions presuppose a Supreme Being.” *Zorach v. Clauson*, 343 U.S. 306, 313 (1952).

We encourage you to continue opening City Council meetings with prayer. Like the Town of Greece, you may wish to invite various clergymen to sign up for voluntary prayers. Many municipalities follow this tradition, as do those state legislatures who do not have paid chaplains. Alternatively, you may wish to use any volunteer chaplains who serve the police or firemen in Aberdeen. We think you will find many clergy of various religions willing to serve the community in this way.

If you are concerned about compliance with the First Amendment, we have lawyers on staff who will work for free with the City attorneys in drafting policies that assure compliance with state and federal law. Thanks in advance for considering this.
